To All AAHW Students and Employees: 2020 Annual Campus Safety & Security Report

Background:

All colleges and universities are required by the U.S. Department of Education to provide an annual report of all instances of specific criminal activity which have been reported on-campus during the previous year, including hate crimes (Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act of 1990, generally called the Clery Act). In 2014, educational institutions were required to include additional disclosures and policy statements to comply with the Violence Against Women Reauthorization Act of 2013 (VAWA). Campus crime surveys document reports of specific types of criminal activities which occur on campus property and adjacent public property (sidewalk and street bordering school property). Each college is required to publish an annual crime report containing the previous three years' worth of crime statistics and distribute it to all students and employees.

***USDE has historically required the annual Campus Safety & Security Report to be completed by educational institutions in August/September of any given year, and posted on the institution's website by September 30th. For AAHW, September of 2021 will be the first year that we will be required to complete and post the Campus Safety & Security Report. Therefore, this Report has been modified from the AAAOM 2020 Report for the purpose of providing AAHW students and employees with background and information about the Campus Safety & Security Report in general.*

The campus crime survey collects data on the reporting of the following criminal activities and incidents: murder/manslaughter, sex offences, robbery, assault, burglary, motor vehicle theft, arson, illegal weapons possession, drug and liquor law violations, and hate crimes. Beginning in 2015, the annual campus crime survey also includes the VAWA-related crimes of domestic violence, dating violence, and stalking. **Note that these statistics refer to reported criminal activity, and not to the determination of whether or not criminal activity has actually occurred.** Please refer to the table below for the statistical results of AAAOM's 2020 crime survey.

Availability of Campus Crime Survey and Crime Log:

When the online Campus Crime Survey is completed, it is downloaded and made available for review in the Campus Security Handbook in the Financial Aid Administrator/Registrar's office. AAAOM surveys completed 2006 - 2020 are available for review. Students and employees may examine these surveys at any time the office is open, and may request a paper copy of the campus security report from the Financial Aid Administrator or Registrar.

In coordination with the annual Campus Crime Survey report, educational institutions are required to provide a crime log of reported crimes on campus premises. Since AAHW does not have an on-campus security department, crime statistics are obtained from the local police department: the Roseville PD. Roseville PD provides a spreadsheet of criminal activities which have been reported for the school's geographic location during the preceding twelve months. This log is also available for inspection by students and employees in the Financial Aid Administrator/Registrar's office. A list of community resources for victims of crime has been compiled by the Roseville PD, and is available in the Campus Security Handbook.

Reporting Criminal Activity:

Maintaining a peaceful, crime-free campus requires a co-operative effort on the part of AAHW administrative staff, faculty and students.

- AAHW does not have a campus police force. **Criminal activity or serious incidents such as the ones listed above should be reported immediately by calling 911. The non-emergency number of the Roseville Police Department is 651-767-0640.** Once the police have been notified, report the incident to a member of AAHW's administrative staff as soon as possible.
- On campus, the Academic Dean is in charge of security issues. However, all administrative personnel are responsible for a first response to an emergency situation until assistance is provided by police, fire, or medical agencies. Students should report any security-related concerns in a timely manner to any member of the administrative staff available at the time, including front desk receptionists, faculty members, and clinic supervisors.
- Non-emergency situations, such as incidents of alcohol possession or sexually inappropriate behavior should be reported to the Academic Dean to begin appropriate investigative and disciplinary action.

VAWA-Related Issues:

Instances of violence against women have become an important issue on many college campuses across the country, promoting much useful dialogue on the subject. With the VAWA Reauthorization Act of 2013, Congress has stepped up efforts to mitigate campus-based incidents of domestic violence, dating violence, and stalking by requiring institutions of higher education to clearly define their response to student reports of such incidents, and to implement policies and procedures outlining the institutions' responsibilities in these cases.

To date, there have not been any reported instances of campus-based domestic violence, dating violence or stalking at AAHW. However, AAHW provides the following policies and procedures for dealing with reports of violence against women which take place on campus property:

- Victims of, and witnesses to, violent actions against anyone on campus should call 911 immediately or notify the Roseville Police Department directly. AAHW condemns violent acts against anyone, and will support the civil authorities/police department to the best of its ability in these cases. In the case of violent actions

reportable to the police, AAHW will use the standards of evidence used and set forth by the police department in any institutional proceeding arising from such a report. Students or staff members of AAHW who commit violent actions on campus property and are found guilty of doing so will be dismissed from the program (students) or terminated as employees (staff).

- Victims of or witnesses to criminal actions, such as stalking, which are not overtly violent, but which cause the victim to fear for her/his safety or cause the victim substantial emotional harm, should report such action(s) to AAHW administration as soon as possible. Victims are also free to report such activity to the police or civil authorities. If the police are involved, AAHW will abide by standards of evidence used by the police to determine whether there is sufficient evidence against an accused perpetrator to warrant institutional actions such as dismissal from the program or termination of employment.
- If a student reports an incident only to AAHW administration, AAHW will undertake to investigate the circumstances of the incident, determine whether a criminal action has taken place, and determine appropriate action to take in regard to both the perpetrator and the victim. To determine if a criminal action has taken place, AAHW requires confirmable evidence, such as emails or voicemails from the perpetrator to the victim, or third-party eyewitness confirmation of criminal actions.
- Students who have been the victim of criminal activity on campus property may request assistance or accommodation from AAHW administration, whether the criminal activity has been reported to the police or not, and whether any disciplinary action has been taken against an accused perpetrator or not.
- Options available for students who have been victims of on-campus criminal acts and violence: Students who feel unsafe in one or more of their academic classes may request an independent-study option to complete a class. Interns or externs in the AAHW Student/Faculty Clinic may refuse to treat a patient if that patient is perceived as a threat to the student. Students who work on campus property may request AAHW administration to intervene in a situation which they perceive as dangerous or threatening to themselves or others. Students may request an escort to a vehicle which is parked in the parking lot of the Roseville Professional Building.

Sex Offender Registry:

The Roseville PD maintains a Sex Offender Registry, under the supervision of Captain Mathwig. Students and employees may call 651-792-7008 to obtain information in regard to sex offenders who may be students or employees of AAHW.
